

## **CLIFICOL** TERMS AND CONDITIONS

ANY PERSON OR ENTITY ("User" or "You") REGISTERED TO USE, OR OTHERWISE ACCESSING, the online database www.clificol.net ("Clificol" or "the Website"), OR ANY OF THE INFORMATION CONTAINED WITHIN THE WEBSITE MUST AGREE TO BE BOUND BY THE FOLLOWING TERMS AND CONDITIONS ("User Agreement").

PERSONAL DATA: You agree to provide only true, accurate and complete information to us via the Website. Any personal information provided by Users, including health and health-related information, will be anonymized in accordance to GDPR regulations.

**Contracting parties.** The Website, the Clificol project, logos and trademarks, together with all software, content, data and other materials contained therein ("Content") are owned and controlled by Zeus Soft sprl, company number BE0647962374, with headquarters at: Rue Jean Sonet 25/3 – 5032 Isnes, Belgium. Zeus Soft sprl is referred to in these terms and conditions as "we", "us", "our", "The Company", "Clificol" or "Zeus Soft". When you register with (or otherwise access) the Website, you are contracting with Zeus Soft sprl. In registering as a member you hereby confirm to be aged 18 or older and agree to these terms and conditions.

- <u>The Clificol Service</u>. Zeus Soft is a private company that owns and manages Clificol. Clificol is an online platform which enables users to upload and visualize anonymized clinical cases. Please note that the use of this service via the Website may be subject to data charges imposed by your internet or mobile phone provider and you will be responsible for payment of any such charges.
- 2. <u>Use of the Service.</u> Use of the Website is limited solely to you, for your own personal noncommercial purposes. You acknowledge that we have the right, at our sole discretion, to terminate your account, or limit or deny access to the Website, or limit the amount of storage space, bandwidth, or other resources you may use. We further reserve the right to terminate any User account with no prior notice to you, including the deletion or retention of any stored content associated therewith.
- 3. **Registration.** You must register with us, and create your own user account, to fully use the Website and the Services provided. When you register for the first time, you will be given access to a standard user account. If you later wish to upgrade to a different account type, you may select this from within the Website. If there are any charges related to the upgrade, you will be made aware of these charges prior to upgrade confirmation. the time of sign-up), you will be notified about these changes in your Clificol account's dashboard.

- 19. <u>Severance.</u> If any part, term, or provision of this Agreement shall be held by a court of competent jurisdiction to be illegal, unenforceable, or in conflict with any relevant law, the remaining portions or provisions shall still remain valid and continue in full force and effect.
- 20. **Variation.** This Agreement may be varied from time to time by our posting new terms on the Website, and any such amendment will be applicable to all Users from the date and time such revised terms have been posted on the Website. Your continued use of the Website and/or the Service constitutes agreement with and acceptance of any such amendment or other changes. We constantly experiment and innovate with the Website in order to provide a better experience for Users and you hereby acknowledge and agree that the form and nature of the Service may change from time to time without prior notice to you.
- 21. <u>Law and Jurisdiction</u>. This Agreement shall be governed by and construed in accordance with the laws of Belgium. Any disputes arising under or in connection with this Agreement shall be subject to the exclusive jurisdiction of the Courts of Namur, Belgium.
